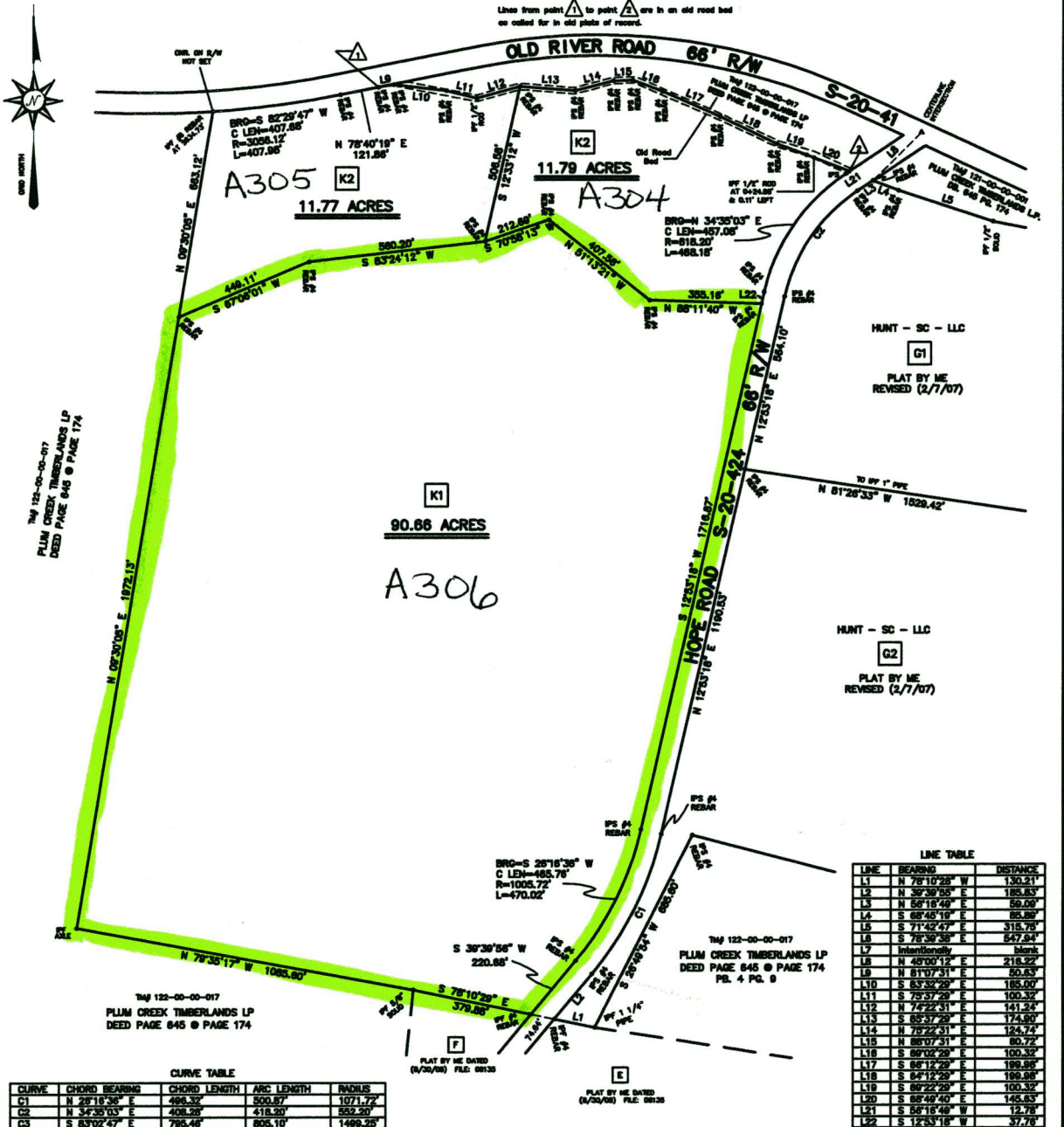


Lines from point  $\Delta$  to point  $\Delta$  are in an old road bed as called for in old plats of record.
