Coleman, Jr., dated May 17, 2005; **being the same** property conveyed to Helen L. Fenwick by deed of partition dated January 7, 1932, recorded in the Clerk's Office of the Circuit Court of Albemarle County, Virginia in Deed Book 218, page 242. 
