Cannon, said right-of-way to be County located along the Quince Cannon boundary line, and being more fully shown and represented on map of 40-foot road right-of-way prepared for Burroughs and Collins Company under date of March 19, 1962 by J. F. Thomas, R.L.S., hereto attached, and by reference made a part of this deed of conveyance.

The right-of-way, being 40 feet in width, extends from County Road to property of Burroughs and Collins Company, known as its J. B. Hardee, Simpson Creek no. 28, Tract, the course of said road being the same as the boundary line between lands of Andrew G. Hardee and Quince Cannon as shown on said map, that is to say beginning at the County Road and running North 9° 05' West 317 feet along a ditch to the end of said ditch; and thence continuing North 10° West 439 feet to stake 0 on the property line of Burroughs and Collins Company, with the said 40-foot road right-of-way lying immediately east of and adjacent to the aforesaid Quince Cannon boundary line.

Burroughs and Collins Company, its successors and assigns, is granted the right to open, maintain, and use this road in perpetuity as a means of ingress and egress for itself, its successors and assigns to and from its lands and out to the County Road.
